The Department has received and reviewed your application to treat Eurasian Watermilfoil and Hybrid Watermilfoil in Horseshoe Lake, Barron/Polk Counties.

After reviewing the permit application, the Department has denied your permit for the following reason under Wisconsin Administrative Code Chapter NR 107.05(3)(c): The department determines that the proposed treatment will not provide nuisance relief, or will place unreasonable restrictions on existing water uses.

- The most up to date information on the waterbody indicates the HWM population is not causing a navigational impairment or nuisance warranting chemical control.
 - o The acreage listed on the submitted permit is 2.33 acres, but the 2021 September survey showed a total of 1.05 acres of HWM.
 - Over the course of the last eight years, the amount of HWM in Horseshoe Lake as identified by fall bed mapping surveys has fluctuated between 1 and about 7 acres in beds (> 50% HWM with a defined edge) and/or high density areas (>25% HWM with a defined edge). These values represent < 1% to about 2.5% of the littoral zone.

Note:

The Department encourages the applicant to continue management efforts in line with their approved aquatic plant management plan.

The approved aquatic plant management plan recommends HWM population levels less than 2.5% be managed with physical and diver removal alone, unless a bed or high density area is located such that it causes a navigational impairment by the public boat landing, is blocking an entrance to an area of the lake, or is situated such that normal boat traffic would likely have to drive through it.

The permit application is not in line with the approved management plan. The criteria listed within the APM plan for Horseshoe Lake states: Unless there are extenuating circumstances, application of herbicide will only be implemented in a given year if the total area supporting bed or high-density area growth reaches or exceeds 2.5% (5-7 acres) of the littoral zone.
